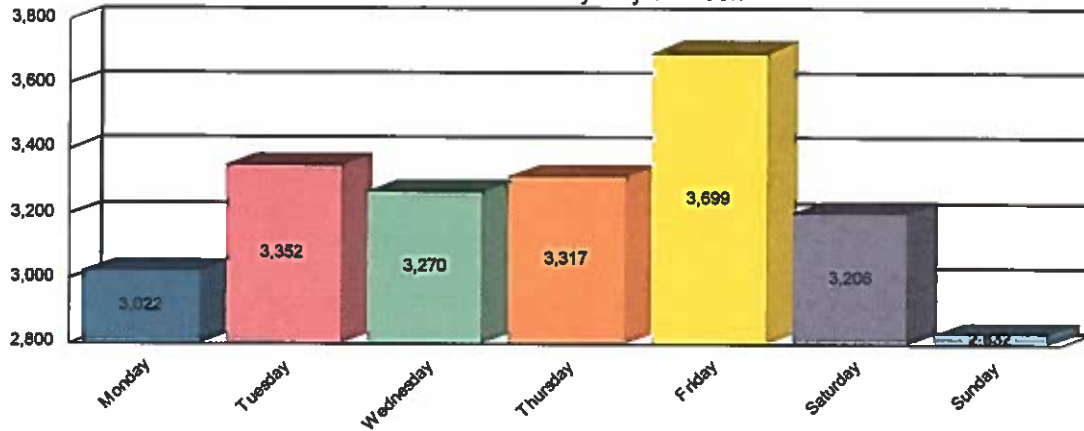

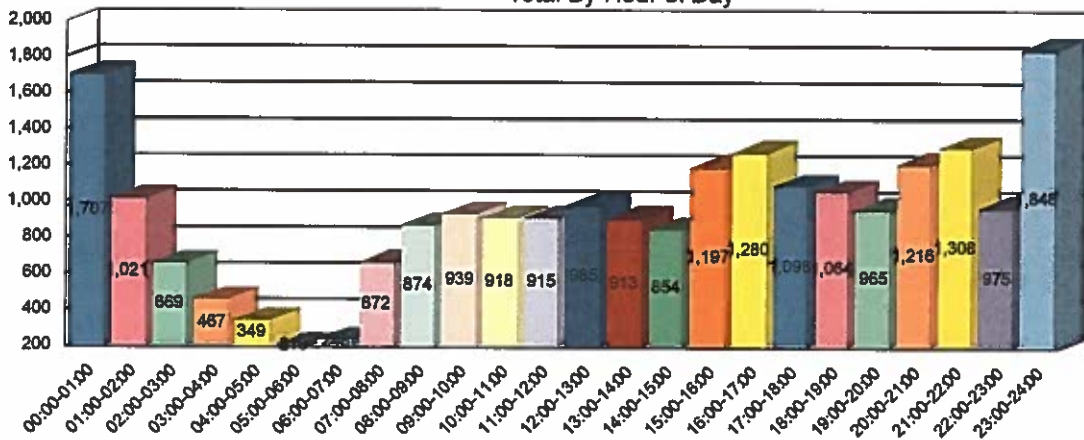
Items For Service Distribution

Criminal Investigations Division

Detectives / Tactical Response Unit / Crime Free Multi-Housing



July / August 2015

The **Criminal Investigations Division (CID)** consists of Detectives, the Tactical Response Unit (TRU), and the Crime Free Multi-Housing Officer (CFMH). For the months of July and August, 2015, the Criminal Investigations Division was assigned a total of 124 cases for further investigation. This does not include the numerous ongoing gang, narcotics, and criminal investigations being conducted with the West Suburban Enhanced Drug/Gang Enforcement (WEDGE) Unit, the West Suburban Major Crimes Task Force (WESTAF), or self-initiated cases created by the Detectives, the Tactical Response Unit, or the Crime Free Multi-Housing Officer.

Of these 124 assigned cases, approximately 80 cases have been cleared, screened, or concluded with an arrest, including 28 arrests resulting in 20 felony charges, 14 misdemeanor charges, 7 local ordinance citations, and 2 warrant arrests.

Forest Park Police Detectives investigated 81 of the most complex criminal investigations assigned during July and August in addition to night and weekend On-Call duties for the Village of Forest Park, and WESTAF call-outs to assist with major criminal investigations.

Among the many highlights, **Detective Petrovic** investigated the nearly fatal Hit and Run (semi truck to pedestrian #15-07-02750), resulting in felony charges. Detective Petrovic also investigated several complicated financial crimes cases, including one resulting in two Class 1 Felony charges against an individual who had stolen mail in Forest Park and subsequently used credit card information from the stolen mail to make fraudulent purchases. When the suspect was arrested he was found in possession of mail, identity, and credit info from several other victims, resulting in the second felony charge. As a WESTAF Group Supervisor, Detective Petrovic also responded to 4 WESTAF callouts for homicide investigations during the month of July.

While resolving numerous other criminal investigations, **Detective Heveran** received approval for a felony forgery charge in Financial Exploitation of the Elderly case #15-03-00829; in which the suspect abused the elderly victim's trust, gained access to the victim's checkbook and had illegally withdrawn over \$9,000.00 USC from the victim's bank account. Detective Heveran also conducted the self-initiated investigation based off of a cyber tip of an unknown suspect in the area who had moved 515 files of child pornography via the internet. Detective Heveran was able to identify the suspect, received approval for a search warrant, and subsequently discovered over 2000 videos of child pornography on the arrestee's computer resulting in a felony charge.

Detective Bryant resolved numerous criminal investigations, including case #15-07-02400 in which a trusted housekeeper stole valuables from homes in Forest Park, Oak Park, and Chicago, while cleaning on behalf of her clients. The victims all knew each other and had all considered the offender a family friend. Using extensive interviews and persistence, Detective Bryant was able to obtain a confession which has resulted in a felony charge in Forest Park, a felony charge in Chicago, and pending charges in Oak Park.

Tactical Response Unit Officers Dan Pater and George Hickey were responsible for the seizure of \$7,050.00 USC during this time period, as well as the seizure of 1 vehicle; a Chevrolet Trailblazer SS. Additional Forest Park highlights include the seizure of 60 grams of cocaine, numerous ecstasy and Zanax pills, and recovery of a pistol reported stolen from a Chicago Police Officer. The TRU also responded to the reported Hit and Run Accident #15-07-02570, in which a victim had her leg severed and nearly died. The TRU quickly located and took the offending driver and vehicle into custody. With TRU assistance, **WEDGE** statistics for the last month included 16 felony charges, 5 misdemeanor charges, 2 search warrants, the seizure of \$4,671.00 USC, and more narcotics than I can list here. The TRU continues to assist neighboring police departments with ongoing narcotics investigations which impact the Village of Forest Park, and are assisting the Federal Bureau of Investigations with a major, long term narcotics investigation stemming from the TRU's own initial investigation. They continue to flex their hours to assist the Patrol Division as needs arise, and work aggressively within Forest Park to close pending criminal investigations and make self-initiated arrests.

Crime Free Multi-Housing Officer Mike O'Connor was assigned 18 investigative cases during this time period pertaining to quality of life issues within the Village of Forest Park. All of the cases have been closed, resulting in 1 arrest, 1 Local Ordinance citation issued, and 3 evictions. CFMH Officer O'Connor continues to monitor 19 Nuisance Properties within the Village of Forest Park, working with tenants, owners, landlords, and neighbors to ensure properties are within compliance of village ordinances. Additionally, CFMH Officer O'Connor continues to work closely with ProCare social worker **Esther Martinez** as she assists residents in Forest Park, and made 8 in-home visits with her in July and August. Officer O'Connor continues to assist Detectives, the Tactical Response Unit, the Patrol Division, and CID Assistant/Evidence Custodian LaShan Riggins daily as their needs arise, and continues to focus on complex quality of life issues on behalf of the department.

CID Assistant / Evidence Custodian LaShan Riggins continues her invaluable assistance in many of the daily operations of the Criminal Investigations Division. Among them, LaShan monitors Critical Reach fliers daily, sharing that information with our officers to increase officer knowledge and safety. LaShan recognized subjects wanted in a Broadview caper matched the description of those wanted in a Brookfield job. LaShan contacted Brookfield PD in reference to this and as a result they discovered their suspects were in custody in Broadview, which lead to confessions and arrests for both departments. Lt. James Burdett from the Brookfield Police Department contacted me to express his thanks, as their case may not have been solved without the tip from LaShan.

In short, the Criminal Investigations Division has been very busy, and because of continued teamwork and thorough efforts from all, very successful for the months of July and August, 2015.

Forest Park Police Detectives, Tactical Officers, and Patrol Officers continue to work together with other jurisdictions in order to solve as many cases as possible. All suspects arrested are considered innocent until proven guilty in a court of law.

- **Narcotics/Assist other agency-** Cook County Sheriffs Police requested K9 Killian for a vehicle search. K9 Killian indicated to the presence of narcotics inside the vehicle but officers could not locate any contraband.
- **Narcotics/Assist other Agency-** Riverside Police Department requested K9 Killian for a narcotic search on a vehicle and an apartment. **K9 Killian located approx. 2.16g of Cocaine and Cannabis.**

12Jul 2015:

14Jul 2015:

K9 Killian indicated to the presence of narcotics inside the vehicle but no narcotics were located. The occupants admitted to possessing cannabis previously in the day.

- **Narcotics/Assist other Agency-** DEA requested K9 Killian for a vehicle search. K9 Killian indicated to the presence of narcotics inside the vehicle and approx. 1 kilogram (900g) of Cocaine was located in a trap along with (2) pistols. (CR#1507-2387)

- **Narcotics/Assist other Agency-** Illinois State Police requested K9 Killian for a vehicle search on I-290. K9 Killian indicated to the presence of narcotics but it is unknown if any narcotics were located. (CR#1507-2404)
- **Building Search-** Sgt. Adams requested K9 Killian for a building search at the Volvo warehouse after an alarm call with an open door. K9 Killian cleared the building and nobody was located inside.

19Jul 2015:

- **Building Search/Area Search/Assist other Agency-** Northlake Police Department requested K9 Killian to look for a Burglary offender. K9 Killian cleared the perimeter of a recycling yard and no offender was located. Based on K9 Killian's deployment, we believe the offender fled E/B on North Ave. (CR#1507-2429)

20Jul 2015:

- **Narcotics-** Ofc. Miller deployed K9 Killian during a traffic stop. **K9 Killian indicated to the presence of narcotics inside the vehicle and .5g of Cocaine was located from inside the vehicle.**

- **Narcotics/Assist other Agency-** DEA requested K9 Killian for a vehicle search. K9 Killian indicated to the presence of narcotics on the exterior and interior of the vehicle but no narcotics could be located. The odor of cannabis was present inside the vehicle. (CR#1507-2451)

- **Narcotics-** Ofc. Miller deployed K9 Killian during a traffic stop. **K9 Killian indicated to the presence of narcotics inside the vehicle and 5.1g of Heroin was located from inside the vehicle.**

- **Area Search-** Ofc. Miller responded with K9 Killian to locate a Robbery offender that fled from Sgt. Bell and was hiding in the school bus parking lot in Maywood. **After Ofc. Miller gave announcements and K9 Killian began to bark, the offender came out of hiding and gave up peacefully. The offender related he gave up to Forest Park Police Units because he did not wish to be bit by K9 Killian.** The offender was charged with Robbery. (CR#1507-2458)

24Jul 2015:

- **Narcotics-** Ofc. Miller located narcotics during a traffic stop and then deployed K9 Killian inside the vehicle. No further narcotics were located inside the vehicle by K9 Killian. (CR#1507-2486)
- **(Narcotics)-** Det. Hickey requested K9 Killian conduct a controlled currency search. **K9 Killian indicated to the presence of narcotics on \$7,050 USC.** (CR#1507-2481)

31Jul 2015:

- **Narcotics-** Ofc. Miller deployed K9 Killian after completing a traffic stop and awaiting the tow. K9 Killian did not indicate or alert to the vehicle as having the presence of narcotics. (CR#1507-2565)
- **Narcotics-** Ofc. Miller deployed K9 Killian on a vehicle after he had Ofc. Reilly stop the vehicle for an IVC violation. K9 Killian did not indicate or alert to the presence of narcotics on the exterior of the vehicle.
- **Narcotics -** Ofc. Miller deployed K9 Killian on a vehicle after he issued the driver a written warning. K9 Killian did not indicate or alert to the presence of narcotics on the exterior of the vehicle.

04AUG15:

- **(Building Search)**- Ofc. Miller and Killian responded to a residential alarm and after Ofc. Miller observed signs of a burglary, he deployed Killian inside the residence to locate any offenders inside. Killian cleared the residence but did not locate anyone inside. (CR#1508-2610)

12Aug15:

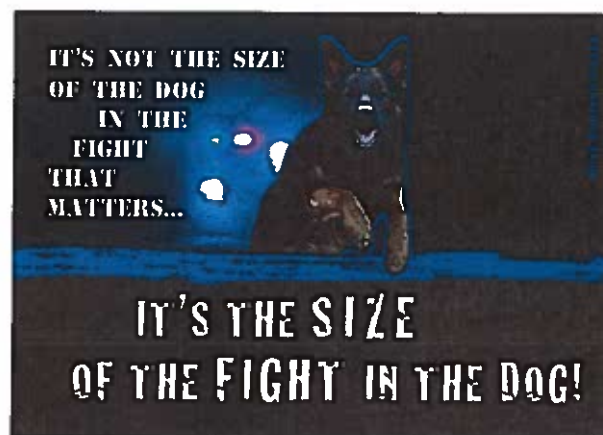
- **Handler Protection/Assist other Agency**- Ofc. Miller responded to River Forest/Oak Park to assist looking for a CTPP offender. Ofc. Miller decided NOT to deploy Killian based on the offense but did bring him out after the offender barricaded himself under a residential porch in Oak Park. After hearing Ofc. Miller's commands and Killian barking at him, the offender came out peacefully. (CR#15-5666-RFPD)

15Aug15:

- **(Building Search)**- After Forest Park Police Units responded to a possible burglary in progress at 8300 Roosevelt, Ofc. Miller deployed Canine Killian inside the building in an attempt to locate anyone hiding inside. Killian cleared the building and did not locate anyone inside. (CR#1508-2762)

*****Ofc. Miller and Canine Killian passed NAPWDA certification which included Narcotics, Obedience, Aggression Control, Area Searches, Article Searches, Tracking and Building Searches. Canine Killian passed all phases of the Certification without any second attempts awarding him the Police Utility Dog Certification as well.**



**FOREST PARK POLICE DEPARTMENT
ASSET SEIZURE AND FORFEITURES
JULY - AUGUST 2015**

Following is a summary of Asset Seizure and Forfeiture activity by the Forest Park Police Department in July - August 2015. All money, vehicle, and property seizures made by this department are in compliance with Illinois Statutes on drug and money laundering forfeiture laws (Illinois Compiled Statutes, Chapter 725, Article 150/5) and other vehicle seizure laws (Chapter 720, Article 36).

NEW CASES:

On 24 July 2015, a defendant suspected of drug sales was stopped and found in possession of a large quantity of cash, bundled consistent with money used in drug sales. Further investigation found the defendant, a documented gang member with numerous arrests for drug delivery, had no reasonable explanation for the money. The money, \$7050 total, was seized. A finding of probable cause to seize this money was found in a preliminary review hearing on 05 August 2015.

On 03 August 2015, a defendant was arrested in possession of more than three pounds of cannabis, mostly hidden in a jet ski being towed by the defendant's truck. The defendant was found in possession of \$3659.64 in cash, which was seized. The defendant's 2007 Dodge Ram truck, estimated value \$21,112, the Sea-Doo jet ski, estimated value \$2000, and the jet ski trailer, estimated value \$500, were all seized from the defendant. On 12 August 2015, a finding of probable cause to seize all cash and conveyances was found in a preliminary review hearing.

On 27 August 2015, a 2006 Chevy Trail Blazer was seized from its owner/defendant, who was arrested for fleeing and eluding police in his vehicle. The vehicle has an estimated value of \$8351. On 09 September 2015, a finding of probable cause to seize the vehicle was found in a preliminary review hearing.

CASES CLEARED:

On 01 July 2015, this department received a Declaration of Forfeiture for \$388 cash that was seized from a defendant in April 2015.

On 02 July 2015, this department received a Declaration of Forfeiture for \$456 cash that was seized from a defendant in April 2015.

On 09 July 2015, this department received a Declaration of Forfeiture for cash in the amount of \$1149 that was seized from a defendant in November 2014.

On 23 July 2015, this department received a Declaration of Forfeiture for cash in the amount of \$591 that was seized from a defendant in May 2015.

On 06 August 2015, this department received a Declaration of Forfeiture for cash in the amount of \$280 that was seized from a defendant in April 2015.

On 19 August 2015, this department received a Declaration of Forfeiture for cash in the amount of \$2050 that was seized from a defendant in May 2015.

On 24 August 2015, this department received a Declaration of Forfeiture for cash in the amount of \$1024 that was seized from a defendant in May 2015.

On 04 August 2015, a check was sent to ISP in the amount of **\$33,214** with award requests for numerous prior monetary seizures that had been declared forfeited to Forest Park Police. This department will receive a check for their 65% portion of that seized money, **\$21,589.10**, which will be used for future narcotics related investigations.

YEAR TO DATE ACTIVITY

So far in 2015, the Forest Park Police Department has initiated 21 new seizure cases. Total cash seized is **\$66,697.64**. Four vehicles and a jet-ski boat have also been seized by this department in 2015.

This department has received a total of **\$12,577.50** from Illinois State Police in 2015, which is our 65% share of seized money, from 17 separate seizure cases.

This department has also been awarded four vehicles in 2015 to be used for police purposes or sold.

Special Response Team

Annual Fitness Test was conducted on Wednesday, July 22nd, every officer except Morrissette and Flores completed the annual fitness test. Flores and Morrissette will complete the test on a later date.

After the annual fitness test a joint terrorist training exercise with the FBI and numerous other organizations was conducted at 933 Harlem. The SRT has been assisting the military and FBI with their homeland security training which runs throughout the summer.

The scenario created involved the Forest Park SRT, while executing a search warrant, discovered a bomb and a laboratory for engineering dirty bombs. The SRT secured the residence and occupants then interrogated the arrestees and gained information which was passed on to the info to the FBI who organized the responding units including the Cook County Bomb Squad, and numerous HAZMAT teams from other area Fire Departments and MABAS.

At the conclusion of the scenario for the FBI, the SRT relocated to the vacant single family residence at 923 Harlem where we conducted three additional search warrant training scenarios where we encounter armed offenders. Prior to our training each officer converted their duty rifle over to UTM. During each of the scenarios the SRT and armed offenders were armed with UTM capable weapons. The SRT performed well under stress while engaging the armed offenders.

Auxiliary Unit

Summary

The auxiliary unit continues to perform foot patrols as part of their volunteer time on Madison St. on Friday nights and Saturday afternoons and evenings.

The unit continues to assist the patrol division with providing security for the Forest Park National Bank, Living Word Church, the local ordinance hearings and various other village functions. The unit continues to send our auxiliary officers to represent the police department at numerous other parades and festivities throughout the suburbs.

July Details:

- **North Riverside Little League Parade:** The North Riverside Police Department invited our department to participate in their annual Little League Parade on July 4th. Aux. Officer Fluker drove one of our squads in the parade.
- **1st Annual Music Festival:** This was the first year for the Forest Park Music Festival. The event was held on Madison Street from Desplaines to Circle Avenue. This event was sponsored by the Forest Park Chamber of Commerce who created this event to replace the Forest Park Summer Festival.

In years past the Chamber organized and ran the event with the assistance of the Forest Park Police Department. This year the Chamber decided to hire an outside contractor to put on the event. The outside contractor provided all the vendors, entertainment and provided their own security, which included cordoning off the perimeter with six foot chain link fencing and requiring a \$5 cover charge to help deter the rowdy behavior that took place at past Summer Fests.

Although the contractor had their own security we supplemented their security with full time, auxiliary and part time police officers throughout the three day event. The Forest Park Officers were tasked with monitoring the perimeter for rowdy behavior and enforcing all Forest Park Village ordinances.

- **No Gloves Softball Tournament:** This Year's "No Gloves Tourney" started on Thursday, July 23rd and ended on Sunday, July 26th with the championship game.

During the four day event officers provided security for the players and the citizens who attended. Officers provided traffic control and monitored the side streets surrounding the event for parking violators and for criminal activity. The auxiliary unit also provided overnight security for each of the nights during the event for the vendor's equipment.

- **Groov'n in the Grove:** On Tuesday, July 21st Auxiliary Officers provided security and traffic control for the "Groov'n in the Grove." The hours for this detail are from 1900 to 2200 Hrs.

August Details:

- **Groov'n in the Grove:** On Tuesday, August 18th two auxiliary officers provided security and traffic control for the "Groov'n in the Grove." The hours were from 1900 to 2200 hrs.
- **Kid's Triathlon:** On Saturday, August 29th the Park District hosted their 4th annual Kids Triathlon. The Triathlon started at 0800 hrs. and concluded at approximately 1030 hrs. The event was cut short due to rain which required the event planners to cancel the bike portion of the race. Since the bike portion was cancelled there was no reason to close Harrison St. so the auxiliary officers who worked the event were only tasked with providing security within the park for the participants, event staff and others who attended.

Training:

Our August auxiliary meeting took place on Friday, August 14th at 1900 hours where we met in the Village Chambers. During our meeting we discussed the up and coming events for the Fall season and addressed officer responsibility issues. Our training was classroom discussion on the following topics.

- **Radio Usage and etiquette:** Some of our newer officers are unsure of when to use their portable radios and what band they should use. During our meeting we reviewed clearance codes and reviewed what radio band they should use as their primary means of communicating with each other and with dispatch.

Use of Force:

- Create classroom scenarios for officers involving passive resister, active resister
- When deadly force is justified
- Levels of force
- Review Department General Order on Use of Force.
- **Complete use of Force module:** Officers will be required to complete the on-line training module (LEA0415 Use of Force module) where they will be watching a series of short videos. Once they have watched the videos they will take short quizzes and then print their certificates. They are required to have this completed by our next meeting/training date on Friday, Sept 11th, 2015.

In future training Sgt. Adams will coordinate with Ofc. Tierney to create real life scenarios for the officers where they will be confronted with circumstances which will challenge their abilities to make quick decisions to use what level of force is necessary for each scenario.



The Forest Park Police Department began offering a Beverage Alcohol Seller and Server Education and Training or BASSET class in 2012. The Forest Park program was approved by the Illinois Liquor Control Commission and Commander Ken Gross licensed by the State of Illinois to instruct the course. The class is approximately four hours in length and consists of a pre and post test.

The goals and objectives of BASSET are to:

1. Train and educate sellers and servers to engage in responsible alcohol service;
2. Spot signs of intoxication and utilize various intervention techniques;
3. Prevent DUIs and alcohol-related fatalities;
4. Stop underage sales and underage drinking;
5. Create safer communities and establishments where alcohol is served;
6. Educate owners, managers and staff on dram shop insurance, state laws, and local ordinances regarding alcohol service.

The BASSET class was initially offered to local liquor establishments upon request and employees in the liquor industry were not required to obtain BASSET certification by village ordinance or state law. Recent changes to the Illinois Liquor Control Act have made it mandatory for bartenders, servers, and those who check identification at liquor businesses within Cook County to obtain BASSET certification by July 01, 2015.

BASSET classes were offered twice monthly from April through June to assist employees at local bars and restaurants in complying with the new state law. In 2015, 128 people have successfully completed the BASSET course given by Commander Gross.
