Criminal Investigations Division

Detectives / Tactical Response Unit / Community Policing



September / October 2017

The Forest Park Police Department's Criminal Investigation Division (CID) is led by Lt. Ken Gross. Three detectives are assigned to CID; Det. Nick Petrovic, Det. Jarlath Heveran, and Det. Rob Bryant. There are two tactical officers in the division; Det. Dan Pater and Det. George Hickey. Officer Mike O'Connor is the police department's Crime Free Multi Unit Housing Officer. LaShan Riggins, the department's Evidence Custodian, is a member of CID and aside from her evidence duties performs administrative duties for the investigators, assists the desk clerks, parking and records. ProCare Crisis Care Worker, Elizabeth Budde, is outsourced to the Forest Park Police Department four times a week and is housed within the CID building located at 501 Desplaines Ave.

The Criminal Investigations Division was assigned a total of 88 cases for further investigation during this period, 44 in September and 44 in October, 28 less than in July / August 2017 and 40 less than in September / October 2016. The cases assigned this period do not reflect older incidents being investigated or ongoing gang, narcotics, and criminal investigations being conducted in-house or with the West Suburban Enhanced Drug Gang Enforcement (WEDGE) Unit, the West Suburban Major Crimes Task Force (WESTAF), Internet Crimes Against Children (ICAC), or self-initiated cases created by the Detectives, the Tactical Response Unit, or the Crime Free Multi Unit Housing Officer.

While investigating both self-initiated and assigned cases, approximately 31 cases have been cleared, screened, or concluded with arrests by the Criminal Investigations Division, resulting in a total of at least 9 felony charges.

WESTAF had three activations in the September to October timeframe. One activation was in Forest Park, one was in Stone Park, and the last one in Melrose Park. All three incidents were stabbings with all investigators assisting with the Forest Park incident and Det. Heveran assisting Stone Park.

Detective Nick Petrovic: Det. Petrovic is the 501 building's detective with the greatest amount of experience in the unit so he oversaw the division while Lt. Gross was on vacation at the end of October. Det. Petrovic arrested a local subject for Aggravated Battery and Hate Crime in an incident at a drinking establishment when the offender battered a patron after using derogatory language (CR# 1702681). The victim was sent to the hospital and the offender fled before police arrival. The victim was identified in photo arrays and arrested. This incident also involved the drafting and execution of a search warrant.

An elderly resident was the victim of a home repair scam with \$1,800 given to the offender (CR# 1702899). An offender was identified by Det. Petrovic, but it was going to be a difficult case to prosecute because of the witness being unable to identify an offender. Det. Petrovic made contact with the offender's family and full restitution was made to the victim.

Det. Petrovic was assigned an identity theft incident where a local lawyer's secretary was found to have been using checks and credit cards belonging to the attorney without his consent while he was hospitalized (CR# 1702512). A great deal of time was put into drafting subpoenas and reviewing video reference this incident. The attorney and only complaining witness in this incident passed away while the case was being built. Det. Petrovic still pursued criminal charges against the offender, arresting and interviewing her, but without a complaining witness felony charges were denied.

A Walmart employee was found to be producing gift certificates for false returns at the store with Walmart's loss nearing \$250,000 (CR# 1702939). This was an incident involving the review of several hours of video footage as well as constant communications with the Walmart store manager and their corporate security management. The end result was the arrest of the employee and a charge of Continuing Financial Crimes Enterprise.

Detective Jarlath Heveran: Due to his tenacity, Det. Heveran worked diligently to identify an armed robbery offender who robbed two subjects at gunpoint outside of the Suburban Fellowship Center (CR# 1702659). Finding where the offender discarded a wallet, Det. Heveran watched video and learned the offender's address and determined the vehicle that he drives. The offender was observed in his vehicle and an attempt to stop the offender led to a pursuit where the offender crashed into the squad car that Det. Heveran was an occupant of. The offender threw a loaded pistol from his auto during the pursuit. The pistol was recovered, but the offender made good his escape. The vehicle was located several days later and administratively towed. Det. Heveran had a warrant issued for the offender who still remains at large.

Det. Heveran assisted patrol in the call of a man with a gun that blossomed into an arrest that netted nearly \$300,000 and several pounds of cannabis (CR# 1702782). Det. Heveran was not only at the scene of the initial call and helped to unfold, but he also drafted search warrants and conducted interviews related to this incident.

Detective Robert Bryant: Det. Bryant took the role of violent crimes detective this period as the lead in two major incidents. The first was an incident that began as an ambulance call and was quickly determined to be a homicide with one brother stabbing another to death in the kitchen of a single family home (CR# 1702799). Det. Bryant worked diligently with peers at the Forest Park PD, WESTAF, witnesses, and the Cook County State's Attorney Office to gather information and lodge a charge of homicide against the offender. It was an exhaustive incident with the offender not admitting wrong doing despite extensive interviews by a number of detectives, including Bryant. Search warrants and subpoenas are still being executed and drafted reference the homicide.

What started as a fight in a bar in late October turned into an attempted homicide with one subject later shooting another subject a number of times in Constitution Court (CR# 1703152). The midnight patrol shift gathered a substantial amount of good information on and from the victim, offenders, and witnesses. They also recovered the firearm used. Both offenders were located and interviewed within ten days of the incident and one subject was charged with attempt homicide.

Tactical Response Unit Officers Dan Pater and George Hickey: Detectives Pater and Hickey assisted the WEDGE task force with the execution of a search warrant in Berwyn that resulted in the recovery of approximately \$5,000, almost 5 pounds of cannabis, and a quantity of prescription medication not belonging to the offender. Det. Pater is a member of NIPAS and was called to Rosemont a number of times reference protests stemming from the death of a young woman who attended a hotel party at a hotel in their town. Both officers are members of the Forest Park PD Special Response Team (SRT).

Crime Free Multi-Housing Officer Mike O'Connor spent much of his time in patrol in the September to October time frame, but continued to monitor 10 CFMH Nuisance Properties within the Village of Forest Park and gather information regarding potential new nuisance properties. Ofc. O'Connor continued his work with **ProCare** crisis care worker **Elizabeth Budde**.


CID Assistant / Evidence Custodian LaShan Riggins manages the daily responsibilities of evidence control for the police department, continues to monitor and disseminate APB's to the Patrol and Investigations Divisions, conducts internet and social media searches to assist Detectives with ongoing criminal investigations, and once again provided her invaluable assistance in many of the daily operations of the Forest Park Police Department Criminal Investigations Division. Ms. Riggins also provides assistance to records, parking, and the non-emergency desk when needed.

Forest Park Police Detectives, Tactical Officers, and Patrol Officers are dedicated public servants who have built and continue to maintain professional relationships within the community and with other agencies in order to solve as many cases as possible.



Criminal Investigations Division

Detectives / Tactical Response Unit / Community Policing



November / December 2017

The Forest Park Police Department's Criminal Investigation Division (CID) is led by Lt. Ken Gross. Three detectives are assigned to CID; Det. Nick Petrovic, Det. Jarlath Heveran, and Det. Rob Bryant. There are two tactical officers in the division; Det. Dan Pater and Det. George Hickey. Officer Mike O'Connor is the police department's Crime Free Multi Unit Housing Officer. LaShan Riggins, the department's Evidence Custodian, is a member of CID and aside from her evidence duties performs administrative duties for the investigators, assists the non-emergency desk, parking and records. ProCare Crisis Care Worker, Elizabeth Budde, is outsourced to the Forest Park Police Department four times a week and is housed within the CID building located at 501 Desplaines Ave.

Police incident reports are reviewed daily. Incidents that have victims wishing to sign a complaint against an offender are assigned to a detective for further review in an effort to develop a suspect, conduct interviews, and gather evidence to effect and arrest and present a winnable case in criminal court. Some incidents are turned over to Elizabeth Budde should there seem to be a need for outreach from her organization. Other incidents, for example, neighbor disputes or landlord tenant disputes, are forwarded to Ofc. Mike O'Connor so he could intervene and, for example, possibly mediate or offer eviction advice. The unit's tactical officers work in a plain clothes capacity and typically self-initiate activity, with a focus on felony crimes and gang and narcotics suppression.

Detectives Petrovic, Heveran, and Bryant are members of the West Suburban Major Crimes Task Force (WESTAF) and are, at times, on call to assist member agencies should a homicide occur. WESTAF was activated one time this period in response to a shooting that took place in River Forest at Harlem and North Avenue (Dec 2, 2017).

Tactical Officers Pater and Hickey are assigned to assist the West Suburban Drug and Gang Enforcement Task Force (WEDGE). A recent uptick in vehicular hijackings among WEDGE communities has resulted in the focus shifting towards locating vehicular hijacking offenders and recovering stolen autos.

Tactical Officers Pater and Hickey attended the Illinois Tactical Officers Association annual conference.

Ofc. Mike O'Connor began acting as a police liaison for four students from the Proviso Math and Science Academy who are in a mentor program. All four students have an interest in law enforcement and as part of their coursework are writing research papers on topics related to investigations and forensics.

There were a total of 89 incidents assigned to detectives this period, 55 in November 2017 and 34 in December 2017. This is one incident more than in September 2017 / October 2017 and 38 less than November / December 2016. There were 57 incidents closed in the November 2017 to December 2017 time frame.


Following are incidents of note in November and December 2017:

- CR# 1703683 Subjects unknown fired multiple rounds from handguns into a home on the 1000 block of Circle. The suspected target and their family, who were not helpful in the investigation, has since moved to a location unknown, but believed to be outside of Forest Park. An area canvass by detectives for witnesses or security camera video reference this incident was negative.
- CR# 1702543 and 1702553 A subject was charged with the felonies Deceptive Practices and Forgery regarding two apartment rental scam incidents where the offender places rental advertisements on Craigslist and poses as a landlord.

- The renters learn that they have fallen victim to a scam after the offender collects the security deposit and the renters are unable to take up residence in the apartment.
- CR# 1703327 November saw a rash of unoccupied autos left running, typically at gas stations or car washes, being stolen with the car thieves driving to the area in stolen autos (chase cars) to commit their motor vehicle thefts. A pattern showed the vehicles being recovered in a specific area on the West Side of Chicago. Armed with this knowledge, detectives located to the area in question shortly after a vehicle was stolen from the Harlem and Randolph Car Wash. The freshly stolen car and chase car were both located with vehicles' occupants fleeing. A juvenile offender was arrested and charged as a result.
- CR# 1703338 and 1703339 Patrol arrested a subject who fled from officers in an auto taken in a Melrose Park Aggravated Vehicular Hijacking a day earlier. While pursuing this offender it was learned that an Aggravated Vehicular Hijacking took place in the area where the pursuit was initiated. The offender was interviewed by detectives and they provided information reference the Forest Park Aggravated Vehicular Hijacking. This led to the arrest of the offender who was found to have committed the Melrose Park Aggravated Vehicular Hijacking as well.
- CR# 1703763 A young lady committed a motor vehicle theft in Elmhurst, IL. The Elmhurst police were able to track the stolen vehicle as it traveled eastbound on I-290. The vehicle exited the expressway at Desplaines Ave and was spotted by CID members who were in covert autos. An attempt to stop the stolen vehicle resulted in the woman fleeing at a high rate of speed and crashing the stolen vehicle into the garden apartment of a building on the 500 block of Jackson. The car thief fled on foot, but was apprehended after a foot pursuit. She was turned over to Elmhurst Police Department who charged her in regards to the incident in their jurisdiction. She is currently being housed at the DuPage County Department of Corrections. Detectives are working with the Cook County States Attorney's Office and will be formally charging the woman for the crimes that occurred in the Village of Forest Park soon.
- CR# 1703332, 1703334, 1703537, and 1703539 Background investigations were completed for three full time police recruits and one part time police officer.

Forest Park Criminal Investigations Division members are dedicated public servants who have built and continue to maintain professional relationships within the community and with neighboring agencies in an effort to quash criminal activity and to solve as many cases as possible.

Forest Park Police Department NARCAN Program – 2017



Naloxone Hydrochloride, aka Narcan, is a safe and effective drug that is used to reverse the effects of opioids.

Narcan was distributed to Forest Park Police personnel April 2016 through June 2016. Narcan was used six times in overdose events in 2016.

There were a total of 11 Narcan uses in 2017, the first, full calendar year of its use being tracked by the Forest Park PD. Narcan was used 2 times in January, 2 times in February, 1 time in April, 1 time in May, 1 time in June, 1 time in September, 2 times in October, and 1 time in November.

The majority of the Narcan in use will expire in 2018. The DuPage Narcan Program will be replacing the current 2ml doses deployed with 4ml doses in 2018 upon the old product expiring.

FOREST PARK POLICE DEPARTMENT ASSET SEIZURE AND FORFEITURES NOVEMBER AND DECEMBER 2017

Following is a summary of Asset Seizure and Forfeiture activity by the Forest Park Police Department in November and December 2017. All money, vehicle, and property seizures made by this department are in compliance with Illinois Statutes on drug and money laundering forfeiture laws (Illinois Compiled Statutes, Chapter 725, Article 1505) and other vehicle seizure laws (Chapter 720, Article 36).

NEW CASES

On 16 November 2017, this department seized \$3,595 cash from a suspect when he was charged with delivery of heroin. Cash was deposited into the Asset Forfeiture account, and paperwork was sent to the State's Attorney Office to initiate seizure. Probable cause to seize this money was found in a preliminary review hearing.

On 01 December 2017, this department seized \$403.72 cash from a suspect when he was arrested in possession of methamphetamine. Cash was deposited into the Asset Forfeiture account, and paperwork was sent to the State's Attorney Office to initiate seizure. Probable cause to seize this money was found in a preliminary review hearing.

On 22 December 2017, this department seized \$1,117 cash from a suspect when he was charged with possession of crack cocaine. Cash was deposited into the Asset Forfeiture account, and paperwork was sent to the State's Attorney Office to initiate seizure. Probable cause to seize this money was found in a preliminary review hearing.

CASES CLEARED

On 21 November 2017, a Settlement Agreement was reached in a seizure of \$3,100 in which the defendant would receive \$800 back, and the remaining \$2,300 would be forfeited to this department. The defendant was furnished with a check for his money, and the remaining seized money is eligible for immediate claim.

On 04 December 2017, a Declaration of Forfeiture was issued in court, indicating that no verifiable claim to \$322 seized from a defendant in July 2017 had been made. That money is eligible for claim 30 days from that date.

On 06 December 2017, a Declaration of Forfeiture was issued in court, indicating that no verifiable claim to \$1,104 seized from a defendant in June 2017 had been made. That money is eligible for claim 30 days from that date.

On 07 December 2017, a Declaration of Forfeiture was issued in court, indicating that no verifiable claim to \$2,266 seized from a defendant in September 2017 had been made. That money is eligible for claim 30 days from that date. On 08 December 2017, a Declaration of Forfeiture was issued in court, indicating that no verifiable claim to \$455 seized from a defendant in September 2017 had been made. That money is eligible for claim 30 days from that date. On 08 December 2017, this department received a check from Illinois State Police for \$19,670.72. This money is from forfeiture cases that have been fully adjudicated and the money awarded to this department for use in future police and drug enforcement efforts. **2017 TOTAL ACTIVITY** In 2017, the Forest Park Police Department initiated 33 new seizure cases. Total cash seized is \$359,549.82. Two vehicles were also been seized by this department in 2017, with a combined estimated value of \$5,638.

SRT Training

The Special Response Team conducted training on September 22nd, 2017 from 0800hrs – 1300hrs at the Kendall County Sheriff's Department Range. Training consisted of weapons drills including live fire drills with pistol and rifle, and focused on Move and Shoot drills, and Stress Shooting drills.

There were no SRT training dates for October, November or December due to staffing issues of scheduled vacations and holidays.

SRT Activations

There were no SRT Activations for the months of September, October, November or December.

Search Warrants

There were no Search Warrants served by the SRT for the months of September, October, November or December.

Accident Investigation

There are no new or pending investigations.

The West Suburban Major Crimes Task Force (WESTAF) has approved the formation of a third branch for Major Crash Investigation, a discipline requiring extensive training and very expensive equipment. Each of the 22 member Departments will be asked to assign at least one Officer and there will be an initial fee to cover the acquisition of the equipment, software and training, then a smaller yearly upkeep fee. These fees represent a fraction of what each Department would have to spend to field a fully equipped and trained crash unit and is a positive development for this Department.

LESO

We have only had one LESO acquisition the last several months. We were able to acquire 25 sets of tactical hearing protection headsets which are worth almost \$900 a pair. They have built-in microphones to amplify outside sound, but cut the sound off when shots are fired to protect the wearers hearing. All SRT members have the same headsets and the 25 acquired should outfit the rest of the Department. These headsets are very useful at the range as they allow all normal hearing, so range commands can be heard, and shut down to protect hearing when gunfire begins.

NIPAS

NIPAS was deployed September 13, 16, 22, 23rd, for protests in Rosemont at the Crown Plaza.

Neighborhood Watch

On December 19th, 2017 the Neighborhood watch had 52 attendees. Mayor Calderone, Chief Aftanas, Commissioner Byrnes, Commissioner Entler, D.C. Keating, Lt. Gross, Sgt. Chin, Ofc. Cannon, and Det. O'Connor were in attendance to field questions and concerns over recent events, i.e. 1000 block Circle shooting and up rise in vehicular hijackings.



Summary

The auxiliary unit continues to perform foot patrols as part of their volunteer time on Madison St. on Friday nights and Saturday afternoons and evenings. The unit continues to assist the patrol division with providing security for the Forest Park National Bank, Living Word Church, the local ordinance hearings and various other village functions.

September Details

Hispano Fest Parade

Melrose Park held their annual Hispano Festival Parade on September 9th, 2017 at 1300hrs. Two auxiliary officers took part in the parade by driving one of our departments marked squads in the procession.

Rib Fest

On Saturday, September 9th, 2017 the 11th annual "Rib Fest" was held in the Altenhiem Picnic Grove. The event began at 1100hrs and ended at approximately 2300hrs. The event drew a large crowd who came to enjoy the rib competition along with live music, food and alcohol. A total of nine auxiliary officers worked the event throughout the day providing traffic control and security.

Living Word Faith Conference

This year's Living Word Faith Conference took place on Monday, September 10th through Saturday, September 15th, 2017. The Church requested two officers to provide traffic control from 2130hrs to 2300hrs each night.

Touch a Truck/Chili Cook Off

On Saturday, September 30th the Park District held their annual Chili Cook Off and "Touch a Truck" event. Two auxiliary officers were assigned to the events from 1200hrs - 1400hrs. The officers included one of the departments marked squads and the Special Response Team truck.

October Details

Proviso East Homecoming Parade

The Proviso East Homecoming Parade was held on October 7th, 2017 at 0800hrs. One auxiliary officer was assigned to drive one of the department's marked squads in the procession.

Casket Races

On Saturday, October 28th, the Forest Park Chamber of Commerce held their annual casket race on the 400 blk of Beloit Ave. Five auxiliary offices were assigned to work the event conducting traffic and crowd control from 0900hrs - 1200hrs.

Zombie Pub Crawl Event

On Saturday, October 28th, the Forest Park Chamber of Commerce held their first annual Zombie Pub Crawl. Persons participating in the event dressed up in their favorite zombie costumes and went from bar to bar along Madison St.

Halloween Detail
